

# KHUMOVEST PRIVATE EQUITY FUND I

## INVESTMENT OBJECTIVE

The Khumovest Private Equity Fund I (the "Fund") has been established to address a key restriction to economic growth in South Africa, being the lack of access to capital available to the small-to-medium enterprise ("SME") sector in South Africa. The principle objective of the Fund is to achieve long term sustainable capital growth by principally investing in SME's while at the same time being a driver for economic growth and job creation.

## INVESTMENT STRATEGY

The Fund will focus on addressing the need for capital within the SME segment of the South African economy. This segment is characterized by companies with the following characteristics:

- Have a full-time staff contingent of between 10 to 200 people; and
- Have an EBITDA of between R10 million and R50 million.

These companies fall within the ambit of SMEs within South Africa.

## ASSET ALLOCATION

The Funds strategic asset allocation will be as follows:

- Growth Capital (equity/quasi equity): 60% - 100%; and
- Acquisition Capital (equity): 0% - 40%.

We believe that this strategic asset allocation is optimal, allowing us to offer growth and acquisition capital. We find that entrepreneurs within the market require equity capital to grow their businesses, however they also look to monetise a portion of the value they have created within their businesses.
